publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the sum of £11,666 13s. 4d. £3 per centum Funding Stock (1959-69) (forming part of the aforesaid sum of £13,331 5s. 3d. £3 per centum Funding Stock (1959-69), or any securities or investments then representing the said sum of £11,666 13s. 4d. £3 per centum Funding Stock (1959-69) together with all the rents and royalties payable to us under the said existing lease and supplemental leases which shall thereafter become due and be received by us under and by virtue of the said existing lease and supplemental leases or of any renewal or renewals thereof or of any lease or leases which may hereafter be granted of the minerals included in the said existing lease and supplemental leases or any part or parts thereof shall cease to be held or received by us for the benefit of the Incumbent of the said Benefice of Gedling and shall be held or received by us for the benefit of our Common Fund to be applied as in the said Acts mentioned.

"And we further recommend and propose that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or Measure or of any of them or of any other Act of Parliament or of any other Measure of the National Assembly of the Church of England."

And whereas the Notice of the foregoing Scheme, which is required by the hereinbefore mentioned Acts, has been given by the said Commissioners to the Patrons of the said Benefice of Gedling, and the said Patrons have not made any objection to the said Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwell.

late Majesty, Chapter II4, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 4th day of March, 1937, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 3rst and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of one moiety of the Advowson or perpetual right of Patronage of and presentation to the Churches and Cure (hereinafter called 'the said United Benefice') of Oake with Hill Farrance, in the County of Somerset and in the Diocese of Bath' and Wells:

"Whereas the said moiety of the Advowson or perpetual right of Patronage of and presentation to the said United Benefice of Oake with Hill Farrance is vested in James Elwin Cockayne Adams, Esquire, the Secretary for the time being of the Board of Charity Commissioners for England and Wales and as such the Official Trustee of Charity Lands, in trust for Prowde's Educational Foundation:

"And whereas Sir Richard Arthur Surtees Paget, Baronet, of Number I Devonshire Terrace, London, Charles Travis Clay, of the Library, House of Lords in the City of Westminster, Esquire, Sir Robert Geoffrey Ellis, Baronet, of Number 10 King's Bench Walk, Temple, in the City of London, Sir Frederick Henry Berryman, of Field House, Shepton Mallet, in the County of Somerset, the Right Honourable Robert, Baron Bayford, Thomas Lionel Dugdale, of Crathorne Hall, in the County of York, a Member of Your Majesty's Commons House of Parliament, and Sir Godfrey Macdonald of the Isles, Baronet, of the County Hall, Beverley, in the said County of York, as the Trustees of Prowde's Educational Foundation (hereinafter called said Trustees'), are desirous that the said moiety of the Advowson or perpetual right of Patronage of and presentation to the said United Benefice of Oake with Hill Farrance now vested as aforesaid, should be transferred to and be vested in the Bishop of Bath and Wells for the time being:
