PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Keg and Drum Trade Board (Great Britain) hereby give notice that they propose to vary minimum rates of wages for male and female workers at present set out in their Notice K.D.(8) dated 31st July, 1935.
