The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:-

REGULATIONS RESPECTING A SPECIAL COMPETItion for Appointment as Second Class Clerk in His Majesty's General Register House, Edinburgh.

I. It is proposed to make at least one appointment-for duty in the Record Officeon the result of this competition, provided a candidate is recommended by the Selection Board as suitable for appointment.

The Keeper of the Registers and Records will take such steps as he thinks most appropriate to announce the competition, and the Civil Service Commissioners will satisfy themselves that the steps taken have been such as to secure all desirable publicity.

2. Applications for appointment must be made to the Keeper of the Registers and Records on the prescribed form not later than the 29th July, 1937.

3. Candidates must have attained 21 years of age and must not have attained 30 years of age

on the 29th July, 1937.

Women candidates must be unmarried or widows and will normally be required to resign their appointments on marriage; but exception to the rule requiring resignation on marriage may, in individual circumstances, be made where the employment of a married woman is considered advisable in the light of her special qualifications, or special experience in relation to the duties required of her, or of the special requirements of the Department.

4. Candidates for appointment to Register House under these Regulations are normally required, where the appointment to be filled is in the Sasines Office, to have passed the examination qualifying for admission as an apprentice to a Law Agent, or an examination of a standard accepted as equivalent by the Civil Service Commissioners and to have served in the office of a Conveyancer practising in Scotland for a period of at least five years after age 16, with the proviso that this period may be relaxed in the case of any candidate who has qualified by examination for a university degree in law.

For appointment to the Record Office, candidates without the above qualifications will be accepted, provided they show that they have received such systematic education, general and/or technical, as in the opinion of the Civil Service Commissioners fits them for the post. In general, candidates for this vacancy should possess a university degree in arts or other equivalent qualification, and should have special qualifications for historical research and preferably some experience in such research.

Evidence on these points must be sent in at such times and in such manner as may be appointed.

5. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.
