WITHDRAWAL OF AUTHORITY.

Whereas Hapuarachige Don Joseph Jayekodi, L.R.C.P., L.R.C.S. (Edin.), L.R.F.P.S. (Glasg.), (formerly Lazarus), of 128, Liverpool Road, London, N.1, has been convicted of offences against the Dangerous Drugs Acts:

And whereas the said Hapuarachige Don Joseph Jayekodi cannot, in my opinion, properly be allowed to be in possession of or to supply any of the drugs or preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

Now, therefore, in pursuance of the powers conferred on me by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said Hapuarachige Don Joseph Jayekodi, the authority granted by the said Regulations to duly qualified medical
