FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1937 (No. 14).

SUBJECT.

Declares the area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

## SCHEDULE.

An Area comprising:—
In the county of Berwick.

The burghs of Eyemouth, Duns and Cold-stream

The parishes of Coldingham, Cockburnspath, Abbey St. Bathans, Cranshaws, Eyemouth, Ayton, Mordington, Foulden, Chirnside, Bunkle and Preston, Duns, Langton, Edrom, Whitsome, Hutton, Ladykirk and Swinton; so much of the parishes of Polwarth, Fogo, Eccles and Coldstream as lies to the east of the road running from Cornhill via Coldstream, Fireburn Cross Roads, Leitholm, Sisterpath, Marchmont Station and Polwarth to Duns, and so much of the parish of Longformacus as lies to the east of the road from Hardens via Longformacus to the junction of the boundaries of the parishes of Cranshaws, Whittingehame and Longformacus.

In the county of East Lothian.

The parishes of Innerwick and Oldhamstocks.

In the county of Northumberland.

The borough of Berwick-upon-Tweed.

So much of the petty sessional division of Norham and Islandshires and of the parishes of Ford and Lowick, as lies to the north of the following boundary, namely, the road running from Coldstream via Cornhill, Barelees, Crookham Westfield, Crookham, Ford Castle, Ford, Barmoor Ridge, Dunsall, Lowick, Kyloe, Fenwick, Fenwick Granary and Fentham to the North Eastern Railway line running from Alnmouth to Berwick, thence northward along the said railway line to the Kyloe-Ancroft parish boundary and thence in an easterly direction following the southern boundary of the parish of Ancroft to the sea.
