time to time be exercised by the said Leonard Hedley, Bishop of Sheffield, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Sheffield.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, and of the Act of the 35th and 36th years of Her said late Majesty, Chapter 14, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 3rd day of June, 1937, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, and of the Act of the 35th and 36th years of Her said late Majesty, Chapter 14, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a Consolidated Chapelry to the consecrated Church of Saint Mary the Virgin, Burgh Heath, situate within the Parish of Banstead in the County of Surrey and in the Diocese of Guildford:

"Whereas at certain extremities of the said Parish of Banstead and of the New Parish (sometime Consolidated Chapelry) of Saint Andrew, Kingswood, in the said County of Surrey and in the Diocese of Southwark, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such Parish and New Parish:

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said Parish of Banstead and of the said New Parish of Saint Andrew, Kingswood, should be formed into a Consolidated Chapelry for all ecclesiastical purposes, and that the same should be assigned to the said Church of Saint Mary the Virgin, Burgh Heath, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend John, Bishop of Guildford, as such Bishop and also as the Patron, in right of his See, of the Vicarage of the said Parish of Banstead, with the consent of the Right Reverend Richard Godfrey, Bishop of Southwark, as such Bishop and also as one of the Patrons of the Vicarage of the said New Parish of Saint Andrew, Kingswood, and with the consents of William Stanley Lloyd, of Spencer Tadworth, in the said County of Surrey, Esquire, Arthur Elliot Riddett, of Long Orchards, Burgh Heath, in the said County Surrey, Esquire, and Arthur Stanley Whitehead, of The Hut, Tadworth aforesaid, Esquire, as the remaining Patrons of the Vicarage of the said New Parish of Saint Andrew, Kingswood (in testimony whereof they the said consenting parties, have respectively signed and sealed this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said Parish of Banstead and of the said New Parish of Saint Andrew, Kingswood, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church of Saint Mary the Virgin, Burgh Heath, situate as aforesaid, and that the same should be named 'The Cosolidated Chapelry of Saint Mary, Burgh Heath ' and that such Consolidated Chapelry should become and be and form part of the said Diocese of Guildford, and should be included within and form part of the Rural Deanery of Epsom and of the Archdeaconry of Dorking, within such last-named Diocese.

"THE SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Mary, Burgh Heath, comprising:—

"All those contiguous portions of the Parish of Banstead, in the County of Surrey and in the Diocese of Guildford and of the New Parish (sometime Consolidated Chapelry) of Saint Andrew, Kingswood, in the said County of Surrey and in the Diocese of Southwark, which taken together are bounded upon the west partly by the Parish of Walton-on-the-Hill and partly by the Parish of Epsom, upon part of the north by the District of Saint Paul, Nork, all in the said County of Surrey and in the said Diocese of Guildford, and upon the remaining sides, that is to say, upon the remaining part of the north, upon the east and
