upon the south, by an imaginary line commencing upon the boundary which divides the said District of Saint Paul, Nork, from the said Parish of Banstead at the junction of Brighton Road with Garratts Lane, and extending thence eastward along the middle of Garratts Lane for a distance of 10½ chains or thereabouts to its junction with Shrubland Road, and extending thence south-eastward along the middle of Shrubland Road for a distance of 101 chains or thereabouts to a point in the wall or fence at its southern end, and extending thence first eastward to and then south-eastward along the wall or fence forming the south-western boundary of the houses and premises situate on the south-western side of Garrard Road for a distance of 8 chains or thereabouts to the point where such wall or fence reaches the northern side of Pound Road, and extending thence first southward to and then eastward along the middle of Pound Road for a distance of 3 chains or thereabouts to a point at its eastern end opposite to the middle of the footpath leading into Holly Lane, and extending thence eastward to and along the middle of the said footpath for a distance of 10 chains or thereabouts to its junction with the footpath leading into Chipstead Road, and extending thence southward along the middle of the last mentioned footpath for a distance of 13½ chains or thereabouts to the point where it reaches the . northern side of Chipstead Road, and extending thence first southward to and then eastward along the middle of Chipstead Road for a distance of 17 chains or thereabouts to a point opposite to the middle of the footpath which leads past the eastern side of Ruffett Wood to Perrotts Farm, and extending thence southward to and along the middle of the last mentioned footpath for a distance of 57 chains or thereabouts to its junction near Perrotts Farm with the footpath leading into Reads Rest Lane, and extending thence first eastward to and then first southward and then eastward along the fence forming the south-western boundary of Banstead Wood for a distance of 22 chains or thereabouts to the point where it meets the boundary which divides the said Parish of Banstead from the Parish of Chipstead, in the said County of Surrey and in the said Diocese of Southwark, and extending thence southward along such boundary for a distance of 8 chains or thereabouts to the point where it meets the boundary which divides the said Parish of Banstead from the said New Parish of Saint Andrew, Kingswood, and extending thence generally westward along the last mentioned boundary (thereby following in part the middle of Waterhouse Lane) for a distance of r mile and 38 chains or thereabouts to the junction of Waterhouse Lane with Brighton Road and the road called Shelvers Way, and extending thence westward along the middle of Shelvers Way for a distance of 58 chains or thereabouts to its junction with Station Road and the road called Shelvers Hill, and extending thence first northward and then westward along the middle of Shelvers Hill for a distance of 7 chains or thereabouts to the centre of the bridge which carries the Chip-stead Valley Branch Line of the Southern Railway across Shelvers Hill, and extending thence northward along the middle of the said line of railway for a distance of 27 chains or thereabouts to the centre of the bridge which carries it across the roadway leading into

Epsom Lane, and extending thence westward along the middle of the said roadway for a distance of 5 chains or thereabouts to the point where it reaches the eastern side of Epsom Lane, and extending thence first diagonally south-westward across Epsom Lane to and then westward along the fence which divides the close numbered I upon the map or plan annexed to this Representation from the close numbered 2 upon the said map for a distance in all of 17 chains or thereabouts to the boundary which divides the said Parish of Banstead from the said Parish of Walton-on-the-Hill."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrars of the said Diocese of Guildford and of the said Diocese of Southwark respectively.

"Now, therefore, we humbly recommend and propose to Your Majesty that we may be authorised and empowered to sell or dispose of and duly to transfer or convey from time to time all or part of the said property described in the said Schedule for such consideration as shall appear to us to be just and reasonable.
