PLYMPTON ST. MARY RURAL DISTRICT ELECTRICITY (EXTENSION).

NOTICE is hereby given that the Rural District Council of Plympton St. Mary (hereinafter called "the Council" and "the District" respectively) whose address is at the Council Offices, Plympton, in the County of Devon, intend to apply to the Electricity Commissioners for a Special Order (hereinafter called "the Order") under the Electricity (Supply) Acts 1882 to 1936 for all or some of the following amongst other purposes (that is to say):—

1. To extend the area of supply within which the Council are authorised to supply electricity so as to include therein the Parish of Ivybridge in the District (hereinafter referred to as "the added area") and to authorise the Council to supply and distribute electricity for all public and private purposes as defined by the Electricity (Supply) Acts 1882 to 1936 within the added area and to prescribe and limit the prices to be charged for electricity supplied therein.

2. To provide for the laying down of electric lines in certain streets and parts of streets in the added area within a period to be specified in the Order.

3. To authorise the Council to open and break up streets and parts of streets in the
