FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1937 (No. 17).

SUBJECT.

Declares the area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

SCHEDULE.

An Area comprising:—

In the county of Chester.
