boundary of the houses and premises situate on the eastern side of Manor Way, and extending thence northward to and along such wall or fence for a distance of 24½ chains or there-abouts to the point where it meets the wall or fence forming the southern boundary of Old Manor Way, and extending thence first eastward to and then north-eastward along the middle of Old Manor Way for a distance of 8½ chains or thereabouts to the centre of the bridge which carries the Bexleyheath Line of the Southern Railway across Old Manor Way, and extending thence eastward along the middle of the said line of railway (thereby following the boundary which divides the said Parish of Crayford from the said New Parish of Saint Paul, Northumberland Heath, Erith) for a distance of 17 chains or thereabouts to the centre of the bridge which carries such railway across a roadway leading into Eversley Avenue where the boundaries of the said Parish of Crayford, of the said New Parish of Saint Paul, Northumberland Heath, Erith, and of the New Parish of Saint Augustine, Slade Green, in the said County and Diocese, all meet, and extending thence northward along the boundary which divides the said New Parish of Saint Augustine, Slade Green, from the said New Parish of Saint Paul, Northumberland Heath, Erith, for a distance of 24 chains or thereabouts to the point where it crosses the middle of Fairford Avenue, and extending thence westward along the middle of Fairford Avenue for a distance of 22 chains or thereabouts to its junction with Appledore Avenue, and extending thence north-westward along the middle of Appledore Avenue for a distance of 3 chains or thereabouts to its junction with Barnehurst Avenue, and extending thence south-westward along the middle of Barnehurst Avenue for a distance of 2 chains or thereabouts to its junction with Coniston Road, and extending thence westward along the middle of Coniston Road for a distance of 141 chains or thereabouts to its western end, and extending thence first northward to and then westward along the wall or fence forming the northern boundary of the house and premises known as Number 54 Coniston Road and the wall or fence in continuation thereof for a distance in all of 4 chains or thereabouts to the point where the last mentioned wall or fence reaches the eastern side of Erith Road, and extending thence first westward to and then southward along the middle of Erith Road (thereby following for a short distance the boundary which divides the said New Parish of Saint Paul, Northumberland Heath, Erith, from the said New Parish of Christ Church, Bexley Heath) for a distance of 6½ chains or thereabouts to a point opposite to the eastern end of the wall or fence forming the northern boundary of Bursted Wood, and extending thence westward to and along such wall or fence for a distance of 18 chains or thereabouts to the point where it reaches the eastern end of Swanbridge Road, and extending thence westward along the middle of Swanbridge Road for a distance of 15 chains or thereabouts to its junction with Heversham Road and the road called The Green, and extending thence generally north-westward along the middle of The Green (following in part its southern arm) for a distance of 15 chains or thereabouts to its junction with Rydal Drive, and extending thence first westward to

and then north-westward along the wall or fence forming the boundary between the houses and premises known as Number 182 and Number 184 Rydal Drive for a distance of 2½ chains or thereabouts to the point where such wall or fence meets the wall or fence forming the boundary between the houses and premises known as Number 66 and Number 64 Bedonwell Road, and extending thence north-westward along the last mentioned wall or fence for a distance of 2 chains or thereabouts to the point where it reaches the eastern side of Bedonwell Road, and extending thence first north-westward to and then south-westward along the middle of Bedonwell Road (thereby following for a short distance the boundary which divides the said New Parish of Christ Church, Bexley Heath, from the New Parish of All Saints, Belvedere, in the said County and Diocese) for a distance of 15½ chains or thereabouts to its junction with Long Lane, and extending thence south-eastward along the middle of Long Lane for a distance of 55 chains or thereabouts to its junction with Erith Road, and extending thence southward along the middle of Erith Road for a distance of 12 chains or thereabouts to its junction with May Place Road at which point the said imaginary line commenced.

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Rochester.
