ROAD TRAFFIC ACT, 1930.

ROAD AND RAIL TRAFFIC ACT, 1933.

NOTICE is hereby given that on the 14th December, 1937, the Minister of Transport confirmed the County Borough of Birkenhead and the Urban District of Bebington (Traffic Regu-lation) Order, 1937; made by the Council of the County Borough of Birkenhead and the then Urban District Council of Bebington under Section 46 (2) of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933. TOWN AND COUNTRY PLANNING ACT, 1932.

NOTICE is hereby given that: (1) on the sixteenth day of December, 1937, the Minister of Health notified his approval of the resolution of the Urban District Council of Enfield dated the twenty-sixth day of October, 1937, deciding to prepare the above planning scheme with reference to an area situate wholly within the Urban District of Enfield; (2) a certified copy of the Map defining the area to which the resolution applies has been deposited at the office of the Council's Engineer and Surveyor, at 7, Little Park Gardens, Enfield, and will be open for inspection by all persons interested without charge between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays, inclusive, and 9 a.m. to 12.30 p.m. on Saturdays; (3) any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the Urban District of Enfield and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Urban District Council of Enfield to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933,* the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Urban District Council of Enfield are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid Map.

The Urban District Council of Enfield intend to proceed as soon as may be with the preparation of a Draft Scheme and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to the Clerk to the Council.
