And whereas I am of opinion that the said David Davidson Watson cannot properly be allowed for the purposes of the Raw Opium, etc. Regulations, 1937, and the Dangerous Drugs Regulations, 1937, to remain an authorised person or to give prescriptions:

Now therefore I hereby cancel, as from to-day's date, the Notice of suspension published in the London Gazette and Edinburgh Gazette on the 29th December, 1933.

COUNTY OF DERBY.

THE CORONERS (AMENDMENT) ACT, 1926.

Order for the alteration of Coroners' Districts.

Whereas on the 1st day of August, 1937, a vacancy occurred in the Office of Franchise Coroner for the Hundred of High Peak and such parishes and townships in the Hundred of Wirksworth in the County of Derby as are within the Honor of Tutbury:

And whereas by the operation of section 4 (1) of the Coroners (Amendment) Act, 1926, the area over which the Franchise Coroner had jurisdiction thereupon, for all purposes relating to Coroners, became merged in the County of Derby:

And whereas by section 4 (2) of the said Act it is provided that where any area in which a Franchise Coroner had jurisdiction is merged in a County which is divided into Coroners' Districts, any consequential alteration of the division of the County into Coroners' Districts shall be affected in manner provided by the Act:

And whereas the said County is divided into three Coroners' Districts:

And whereas the Council of the said County has pursuant to section 12 of the said Act and to the Coroners (Orders as to Districts) Rules, 1927, submitted to the Secretary of State a draft Order providing for the alteration of the existing division of the said County into Coroners' Districts.
