The parishes of Thorncombe, Broadwindsor, Burstock, Seaborough, Stoke Abbott, Mosterton, South Perrott, Chedington and Halstock.

In the county of Somerset.

The boroughs of Bridgwater, Taunton, Chard, Glastonbury, Wells, Yeovil and

Weston-super-Mare.
