Notice is hereby given, in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Orders:—

Order No. 5645.

(Dated 7th February, 1938.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 35).

SUBJECT.

I. Declares the area described in the First Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions)

Order of 1925 and includes the Foot-and-Mouth Disease Infected Area around Shedfield, Hampshire in that Area.

II. Revokes the Orders described in the Second Schedule.

FIRST SCHEDULE.

An Area comprising:—

In the county of Southampton.

The city and county borough of Portsmouth.

The city of Winchester.

The county borough of Southampton.

The boroughs of Gosport, Romsey and Eastleigh.

The petty sessional divisions of Alresford, Droxford, Fareham, Eastleigh, including its detached part, Winchester (*except the parishes of Crawley, Little Somborne, and Ashley; so much of the parish of Sparsholt as lies to the north of the road running from Littleton via Lainston House and Sparsholt Church to Kings Somborne, and except the said road; and so much of the parish of Kings Somborne as lies within the said petty sessional division*) and Petersfield (*except the parishes of Greatham, Liss, Hawkley, Rowland's Castle and Bramshott*).

The parishes of Steventon, North Waltham, Popham, Dummer with Kempshot, Woodman-cott, Nutley, Preston Candover, Bradley, Wild, Bentworth, Medstead, Four Marks, Chawton, Farringdon, Newton Valence, East Tisted, Marchwood, Dibden, Fawley, Eling, Netley Marsh, Nursling and Rownhams, North Baddesley and Ampfield; so much of the parish of Romsey Extra as lies to the south-east of the road running from Braishfield via Woodley Lodge, Pauncefoot and Blackwater Bridge to Cadnam; so much of the parish of Copythorne as lies to the south-east of, and including, the main road running from Romsey via Blackwater Bridge and Cadnam to Stony Cross; so much of the parish of Denny Lodge as lies to the east of the Southern Railway line running from Totton Station to Brockenhurst; so much of the parish of Havant as lies to the north and west of the Southern Railway line running from Rowland's Castle to Portsmouth; so much of the parish of Alton as lies to the south-west of the boundary consisting of the Southern Railway line running from Basingstoke to its junction with the railway line from Alton thence following that line to Medstead Station; and so much of the parishes of Laverstoke and Overton as lies to the south of the Southern Railway line running from Basingstoke to Whitchurch.
