

*In the petty sessional division of Taunton:—*

The parishes of Stoke St. Gregory, North Curry, Durston, West Monckton, Creech St. Michael, Ruishton, Thorn Falcon, West Hatch, Hatch Beauchamp, Bickenhall, Curland, Staple Fitzpaine and Orchard Portman; and so much of the parish of Stoke St. Mary as lies to the east of the road running from Corfe via Fullands and Mountlands to Taunton.

**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 40).****SUBJECT.**

1. Contracts the Foot-and-Mouth Disease Infected Area around Owslebury, Hampshire, as from the 22nd February, 1938, so as to comprise only the area described in the Schedule.

2. Releases the Foot-and-Mouth Disease Infected Area around Owslebury, Hampshire, from restrictions, and revokes Order No. 5645, as from the 2nd March, 1938.

**SCHEDULE.***Contracted Infected Area.*

An area in the county of Southampton comprising:—

The city of Winchester.

The borough of Eastleigh.

*In the petty sessional division of Winchester.*

The parishes of Chilcomb, Owslebury, Twyford, Golden Common, Otterbourne, Compton; so much of the parish of Itchen Valley as lies to the south of the road running from Ovington Park via Matterly Farm and New Inn to Winchester; and so much of the parish of Hursley as lies to the south of the road running from Chandler's Ford via Hillingbury, Ladwell, Southend House and Bunstead to the Southampton-Winchester Road.

*In the petty sessional division of Eastleigh.*

The parishes of Fair Oak, Botley, Hedge End and so much of the parish of West End as lies to the north-east of the road running from Swaythling via Westend Mills, West End Church and Moorhill to Hedge End.

*In the petty sessional division of Alresford.*

The parishes of Kilmeston, Beauworth, so much of the parishes of Cheriton and Titchborne as lies to the south-west of the road running from Kilmeston Church via Hinton Marsh, Cheriton Church, Cheriton Mill, Titchborne Park and Titchborne Down to New Alresford; and so much of the parish of Itchen Stoke and Ovington as lies to the south of the road running from New Alresford via Ovington Park and Matterly Farm to Winchester.

*In the petty sessional division of Droxford.*

The parishes of Soberton, Corhampton and Meonstoke, Droxford, Swanmore, Shedfield, Curdridge, Durley, Bishop's Waltham and Upham; so much of the parishes of Exton and

Warnford as lies to the west of the road running from Kilmeston via College Down Farm, Beacon Hill and Winter's Down to Droxford; and so much of the parishes of Denmead and Hambleton as lies to the west of the road running from Creech Farm via Denmead Church, Pithill Farm, Pithill and Hambleton Church to Grenville Copse.

*In the petty sessional division of Fareham.*

The parishes of Curbridge and Wickham; and so much of the parishes of Fareham, Boarhunt and Southwick and Widley as lies to the north-east, north and north-west of the following boundary namely the Fareham Branch of the Southern Railway line running from Bursledon to its junction with the Portsmouth Branch line of the Southern Railway, thence following that line to its junction with West Street, Fareham, thence following the road via West Street, East Street, Bridgefoot Hill, Cams Hill, Portchester Road, and Downend Road, thence following the road running via Fort Nelson, Offwell Farm, Southwick Church and Creech Farm to Denmead Church.

Proceedings under Section 24 of the Acts.
