

Geoffrey Pennyman being the present Incumbent of the said Benefice of North Audley Street, Saint Mark:

" And whereas the Patronage of the said Benefice of Davies Street, Saint Anselm, now belongs to the Incumbent for the time being of the said Benefice of Saint George, Hanover Square:

" Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consents of the said Arthur Foley, Bishop of London, Henry Colville Montgomery-Campbell and William Geoffrey Pennyman (testified by their respectively signing this Scheme) do humbly recommend and propose to Your Majesty as follows, that is to say:—

" 1. That the said Benefice of Saint George, Hanover Square, and the eastern part of the said Benefice of Davies Street, Saint Anselm, that is to say, so much of the said Benefice of Davies Street, Saint Anselm, as lies to the east of the middle of Davies Street, shall be permanently united together and form one Benefice with Cure of Souls and one Parish for ecclesiastical purposes under the style of ' the Benefice of Saint George, Hanover Square ' (hereinafter referred to as the United Benefice of Saint George, Hanover Square).

" 2. That the said Benefice of North Audley Street, Saint Mark, and the remaining part of the said Benefice of Davies Street, Saint Anselm, shall be permanently united together and form one Benefice with cure of Souls and one Parish for ecclesiastical purposes under the style of ' the Benefice of North Audley Street, Saint Mark ' (hereinafter referred to as the United Benefice of North Audley Street, Saint Mark).

" 3. That the Church of the Parish of Saint George, Hanover Square, shall be the Parish Church of the United Parish of Saint George, Hanover Square, and that the Table of Fees for the said Parish of Saint George, Hanover Square, shall (until revised or altered by proper authority) be the Table of Fees for the same United Parish.

" 4. That the Church of the Parish of North Audley Street, Saint Mark, shall be the Parish Church of the United Parish of North Audley Street, Saint Mark, and that the Table of Fees for the said Parish of North Audley Street, Saint Mark, shall (until revised or altered by proper authority) be the Table of Fees for the same United Parish.

" 5. That if upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the said Benefice of Davies Street, Saint Anselm, shall be vacant then the unions shall forthwith take effect, but if upon that day the said Benefice of Davies Street, Saint Anselm, shall be full, then the said unions shall take effect immediately upon the first vacation thereafter of the said Benefice of Davies Street, Saint Anselm, and in either case the said Henry Colville Montgomery-Campbell, if he is then Incumbent of the said Benefice of Saint George, Hanover Square, shall be the first Incumbent of the United Benefice of Saint George, Hanover Square, and the said William Geoffrey Pennyman if he is then Incumbent of the said Benefice of North Audley Street, Saint Mark, shall be the first Incumbent of the United Benefice of North Audley Street, Saint Mark.

" 6. That if within the period of six calendar months immediately following the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the said Robert Henry Sinclair shall with the consent of the said Bishop of London retire from the said Benefice of Davies Street, Saint Anselm, in order that the said unions may take immediate effect then he shall be entitled to receive by way of compensation an annual sum of £300, such annual sum of £300 to be reserved by us, the said Ecclesiastical Commissioners, for the payment of such compensation out of the income arising from the part of the endowments of the said Benefice of Davies Street, Saint Anselm, in regard to which provision is hereinafter made in Clause 10 of this Scheme; and the said annual sum of £300 shall commence as from the day upon which the said unions shall take effect and shall be payable by equal quarterly instalments on the first day of February, the first day of May, the first day of August, and the first day of November in every year the instalment so first becoming due being an apportioned part only of the said annual sum in respect of the period between the day of the date of the unions taking effect and the first quarterly day of payment next ensuing and the said annual sum shall be payable by us to the said Robert Henry Sinclair during the remainder of his life subject, however, to the same conditions as to suspension or forfeiture as a pension granted to a retiring Incumbent under the provisions of the Clergy Pensions Measures, 1926 to 1936 and the provisions of those Measures as to such conditions as aforesaid shall apply to the said annual sum and to the said Robert Henry Sinclair as if the said annual sum formed a pension granted under the said Clergy Pensions Measures, and the said Robert Henry Sinclair had resigned the said Benefice of Davies Street, Saint Anselm, under those Measures.

" 7. That upon the unions taking effect the register books of baptisms, marriages and burials and other the records and muniments deposited in the Church of Saint Anselm, Davies Street, shall (save as hereinafter provided) be transferred to the Parish Church of the United Benefice of North Audley Street, Saint Mark, but the marriage registers in duplicate current at the Church of Saint Anselm, Davies Street, shall first be sent by the Incumbent of the United Benefice to the Registrar General to be closed officially: Provided, however, that such of the register books and other the records and muniments deposited in the said Church of Saint Anselm, Davies Street, as relate exclusively to the former Hanover Chapel shall be transferred to the Parish Church of the United Benefice of Saint George, Hanover Square.

" 8. That upon the said unions taking effect (a) the Parsonage House at present belonging to the said Benefice of Saint George, Hanover Square, shall become and be the house of residence for the Incumbent of the United Benefice of Saint George, Hanover Square; (b) the Parsonage House at present belonging to the said Benefice of North Audley Street, Saint Mark, shall become and be the house of residence for the Incumbent of the United Benefice of North Audley Street, Saint Mark, and (c) so soon as conveniently may be the
