

" And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

" THE SCHEDULE to which the foregoing Scheme has reference.

" The District of Saint Martin, Rough Hills, comprising:—

" All those contiguous portions of the New Parish (sometime Consolidated Chapelry) of Saint Luke, Blakenhall, of the New Parish (sometime Particular District) of the Holy Trinity, Ettingshall, and of the Parish of Sedgley, all in the County of Stafford and in the Diocese of Lichfield, which taken together are bounded upon all sides by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Luke, Blakenhall, from the said Parish of Sedgley at the junction of Parkfield Road with Dudley Road, and extending thence first south-eastward and then southward along the middle of Dudley Road (thereby following for some distance the last mentioned boundary) for a distance of 50 chains or thereabouts to its junction with the road leading to Ettingshall Park Farm, and extending thence south-eastward along the middle of the last mentioned road for a distance of $23\frac{1}{2}$ chains or thereabouts to its junction with the roadway or footpath leading north-eastward into Birmingham Road, and extending thence first north-eastward and then eastward along the middle of such roadway or footpath for a distance of $22\frac{1}{2}$ chains or thereabouts to its junction with Birmingham Road, and extending thence north-westward along the middle of Birmingham Road for a distance of $11\frac{3}{4}$ chains or thereabouts to its junction with the roadway or footpath leading into Martin Street, and extending thence first north-eastward and then northward along the middle of the last mentioned roadway or footpath (thereby crossing the boundary which divides the said Parish of Sedgley from the said New Parish of the Holy Trinity, Ettingshall) for a distance of 24 chains or thereabouts to its junction with Martin Street, and extending thence northward along the middle of Martin Street for a distance of $10\frac{1}{2}$ chains or thereabouts to its junction with Parkfield Road, and extending thence eastward along the middle of Parkfield Road for a distance of $1\frac{3}{4}$ chains or thereabouts to the point where the boundary of the County Borough of Wolverhampton diverges northward from following the middle of Parkfield Road, and extending thence first northward and then eastward along such County Borough Boundary for a distance of 9 chains or thereabouts to the point where it crosses the middle of Rooker Avenue, and extending thence north-westward along the middle of Rooker Avenue for a distance of $23\frac{1}{2}$ chains or thereabouts to its junction with Dixon Street and extending thence south-westward along the middle of Dixon Street (thereby crossing the boundary which divides the said New Parish of the Holy Trinity, Ettingshall, from the said New Parish of Saint Luke, Blakenhall, for a distance of $15\frac{1}{2}$ chains or thereabouts to a point opposite to the eastern end of the wall or fence forming the northern boundary of the premises attached to

the Black Horse Hotel, and extending thence westward to and along the said wall or fence for a distance of $4\frac{1}{2}$ chains or thereabouts to the point where it reaches the eastern side of Thompson Avenue, and extending thence first westward to and then southward along the middle of Thompson Avenue for a distance of 2 chains or thereabouts to its junction with the roadway leading between the houses and premises known as Number 61 and Number 63, Thompson Avenue, and extending thence generally south-westward along the middle of such roadway and along the fences which divide the close numbered 409 upon the Ordnance Survey Map of the County Borough of Wolverhampton published in the year 1919 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme from the closes numbered 410 and 421 upon the said maps and from the premises attached to the Old Ash Tree Public House for a distance in all of $21\frac{1}{2}$ chains or thereabouts to the point where such fence reaches the eastern side of Dudley Road, and extending thence first westward to and then southward along the middle of Dudley Road for a distance of 5 chains or thereabouts to its junction with Parkfield Road, at which point the said imaginary line commenced."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have with the exceptions hereinafter mentioned respectively signified their assent to such Scheme:

And whereas the Vicar or Incumbent of the Vicarage of the said New Parish of Saint Luke, Blakenhall, the Patrons of the Vicarage of the same New Parish, and the Vicar or Incumbent of the Vicarage of the said New Parish of the Holy Trinity, Ettingshall, have offered certain objections to the said Scheme:

And whereas notwithstanding the said objections the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lichfield.
