Chelsfield Lane for a distance of 22 chains or thereabouts to Saunder's Cross, and extending thence first south-eastward to and then first south-eastward and then southward along the footpath leading between Saunder's Spring Wood and Barnett's Wood, for a distance in all of 18 chains or thereabouts to its junction with the footpath leading along the southern side of Barnett's Wood, and extending thence south-eastward along the middle of the last mentioned footpath for a distance of 92 chains or thereabouts to its eastern end, and extending thence south-eastward in a straight line for a distance of 4 chains or thereabouts to the northern end of the fence forming the western boundary of Jenkin's Neck Wood, and extending thence south-eastward along such fence for a distance of II chains or thereabouts to the point where it crosses the middle of the footpath leading into Orpington By Pass Road, and extending thence westward along the middle of the said footpath for a distance of 14 chains or thereabouts to its junction with the roadway or footpath leading to Badger's Mount, and extending thence southward in a straight line across Jenkin's Neck Wood for a distance of 31 chains or thereabouts to the point where the fence forming the western boundary of such wood turns westward, and extending thence southward along the said fence for a distance of 201 chains or thereabouts to the point where it reaches the northern side of Shacklands Road, and extending thence first southward to and then westward along the middle of Shacklands Road for a distance of 3 chains or thereabouts to the point where it crosses the middle of the Polhill Tunnel of the above mentioned main Line of the Eastern Section of the Southern Railway, and extending thence southeastward along the course of Polhill Tunnel for a distance of 70 chains or thereabouts to the point where it is crossed by the fence forming the south-eastern boundary of the wood lying to the east of the road called Old Polhill, and extending thence first south-westward and then southward along the middle of such fence for a distance of 21 chains or thereabouts to the point where it reaches the eastern side of Old Polhill, and extending thence first westward to and then southward along the middle of Old Polhill for a distance of 3 chains or thereabouts to the boundary which divides the said Parish of Shoreham from the said New Parish of Saint John, Dunton Green.

"THE FOURTH SCHEDULE.

"The territory to be dissevered from the said Parish of Farnborough and to be annexed to the said Parish of Orpington, being:—

"All that portion of the said Parish of Farnborough which is bounded upon the north and upon the east by the said Parish of Orpington and upon the remaining side, that is to say, upon the south-west, by an imaginary line commencing upon the boundary which divides the said Parish of Orpington from the said Parish of Farnborough at the centre of the bridge which carries the above mentioned Main Line of the Eastern Section of the Southern Railway across Sevenoaks Road, and extending thence north-westward along the middle of the said line of railway for a distance of $32\frac{1}{2}$ chains or thereabouts to the centre of the bridge which carries it

across Tubbenden Lane upon the boundary which divides the said Parish of Farnborough from the said Parish of Orpington."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the said Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Rochester has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measures.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Rochester.
