#### SILEBY GAS.

(Application for Special Order under the Gas Undertakings Acts, 1920 to 1934.)

NOTICE is hereby given that The Sileby Gas Light and Coke Company Limited (hereinafter referred to as "the Company") whose registered office is at High Street Sileby in the county of Leicester intend to apply to the Board of Trade for a Special Order under the Gas Undertakings Acts, 1920 to 1934, for all

or some of the following purposes (that is to say):—

To authorise the Company to supply gas within the parishes of Cossington Seagrave and Sileby in the rural district of Barrow-upon-Soar in the county of Leicester (hereinafter referred to as "the limits of supply");

To authorise the Company to continue maintain and use any gas mains pipes and works belonging to them within the limits of supply and to apply to such mains pipes and works the provisions of the intended Order and of the Acts incorporated therewith;

To increase define and limit the capital and borrowing powers of the Company for the purposes of the undertaking to be authorised by the intended Order and to make provision as to the sale of capital of the Company by auction or tender;

To make provision as to the profits of the Company in respect of the said undertaking which may be divided among the shareholders of the Company and the rate of interest upon money borrowed by the Company;

To empower the directors of the Company to reserve a proportion of any future issue of capital for exclusive offer to employees and to consumers of gas of the Company and to make provision as to the conditions of issue;

To empower the Company with the consent of the Board of Trade to offer capital for subscription by employees and consumers of gas of the Company without first offering the same for sale by public auction or tender and to make provision as to the conditions of such offer;

To empower the Company to purchase by agreement lands; to authorise the Company to purchase or take on lease houses cottages and other buildings for employees and offices and showrooms and to erect fit up maintain and let such buildings;

To empower the Company to maintain erect alter improve and renew gasworks with all necessary machinery and apparatus and to make and store gas and to work up and convert residual products upon the lands hereinafter described, and to purchase and use material required to work up and convert residual products;

The said lands are:—
