

The petty sessional divisions of Bearsted, Sittingbourne, Faversham, Malling (*except the parishes of Stansted, Wrotham, Trottscliffe, Ryarsh, Addington, Offham, Platt, Borough Green, Ightham, Plaxtol, Mereworth and West Peckham*); and Cranbrook (*except so much of the parishes of Hawkhurst and Sandhurst as lies to the south and west of the road running from Newenden via Sandhurst and Highgate to Ticehurst, and except so much of the parish of Goudhurst as lies to the south-west of the road running from Sprayhill via Chingley Wood, Stone Crouch and Flimwell House to Hurst Green*).

FENNY STRATFORD GAS.

(Application for a Special Order under the Gas Undertakings Acts, 1920 to 1934.)

NOTICE is hereby given that the British Gas Light Company Limited (hereinafter referred to as "the Company") whose registered office is at 2, The Abbey Garden, in the City of Westminster, intend to apply to the Board of Trade for a Special Order under the Gas Undertakings Acts, 1920 to 1934, with respect to the Fenny Stratford undertaking of the Company for all or some of the following purposes (that is to say):—

To authorise the Company to supply gas within the following areas in the County of Bucks (hereinafter referred to as "the limits of supply") viz.:—

The urban district of Bletchley;

In the rural district of Newport Pagnell—

The parishes of Bow Brickhill Broughton Little Brickhill Loughton Milton Keynes Shenley-Church-End Walton and Woughton-on-the-Green.

So much of the parish of Woolstone-cum-Willen as prior to the coming into operation of the Bucks Review Order, 1934, formed the parishes of Great Woolstone and Little Woolstone;

In the rural district of Wing—

The parishes of Great Brickhill and Stoke Hammond;

In the rural district of Winslow—

The parishes of Drayton Parslow Little Horwood Mursley-with-Saldin Newton Longville Shenley-Brook-End Stewkley and Whaddon.

To authorise the Company to continue maintain and use any gas mains, pipes and works belonging to them within the limits of supply and to apply to such mains, pipes and works the provisions of the intended Order and of the Acts incorporated therewith.

To empower the Company to expend capital for the purposes of their undertaking; to define the expression "paid up capital" and to limit the profits receivable by the Company.

To empower the Company to maintain erect alter improve and renew gasworks with all necessary machinery and apparatus and to make and store gas and to work up and convert residual products upon the lands hereinafter described, and to purchase and use material required to work up and convert residual products.

The said lands are:—

1.
