"Whereas we are satisfied that the said Parish of West Wickham, the said Parish of Hayes, the said Parish of Bromley, and the said New Parish of Saint Barnabas, Beckenham, are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the par-ticular portions of the said Parish of West Wickham, of the said Parish of Hayes, of the said Parish of Bromley, and of the said New Parish of Saint Barnabas, Beckenham, which hereinafter mentioned and described, should be constituted a separate District in the manner which is hereinafter set forth:

And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use

for the purposes of Divine Worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

And whereas the said grant of the said yearly sum of £200 will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chap-

"Now, therefore, with the consent of the Right Honourable and Most Reverend Cosmo Gordon, Archbishop of Canterbury, and with the consent of the Right Reverend Martin, Bishop of Rochester (in testimony whereof they have respectively signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said Parish of West Wickham, of the said Parish of Hayes, of the said Parish of Bromley, and of the said New Parish of Saint Barnabas, Beckenham, which are described in the Schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed, shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be constituted a separate District for spiritual pur-poses and that the same shall be named 'The District of Saint Mary of Nazareth, West Wickham,' and that such District shall become and be and form part of the said Diocese of Canterbury, and shall be included within and form part of the Rural Deanery of Croydon and of the Archdeaconry of Croydon, within such last named Diocese.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Mary of Nazareth,

West Wickham, comprising:-

"All those contiguous portions of the Parish of West Wickham, in the County of Kent and in the Diocese of Canterbury, of the Parish of Hayes, of the Parish of Bromley, and of the New Parish (sometime District) of Saint Barnabas, Beckenham, all in the said County of Kent and in the Diocese of Rochester, which taken together are bounded upon part of the south-west by the New Parish of Saint Francis of Assisi, West Wickham, in the said County of Kent and in the said Diocese of Canterbury, upon the remaining part of the south-west and upon the west by the Consolidated Chapelry of Saint John the Baptist, Beckenham, in the said County of Kent and in the said Diocese of Rochester, and upon the remaining sides, that is to say, upon the north, upon the east and upon the south-east by an imaginary line commencing upon the boundary which divides the said Consolidated Chapelry of Saint John the Baptist, Beckenham, from the said New Parish of Saint Barnabas, Beckenham, at the junction of South Eden Park Road with the proposed new road leading to Barnfield Wood Road, and extending thence eastward along the middle of such proposed new road for a distance of 45 chains or thereabouts to its junction with Wickham Way, Barnfield Wood Road and Red Lodge Road, and extending thence north-eastward along the middle of Barnfield Wood Road for a distance of 45 chains or thereabouts to its junction with Hayes Westmoreland Road, and Pickhurst Lane (upon the boundary which divides the said New Parish of Saint Barnabas, Beckenham, from the said Parish of Bromley) and extending thence north-eastward along the middle of Westmoreland Road for a distance of 10 chains or thereabouts to its function with the road called Pickhurst Park, and extending thence south-eastward along the middle of Pickhurst Park for a distance of 6 chains or thereabouts to the point where it is crossed by the boundary of the Borough of Beckenham, and extending thence first south-westward and then in various directions along such Borough boundary (thereby crossing the boundary which divides the said Parish of Bromley from the said Parish of Hayes) for a distance of 79 chains or thereabouts to the point where the said Borough boundary diverges south-eastward from following the fence forming the south-eastern boundary of the Wickham Park Sports Club Ground and extending thence first south-westward and then north-westward along the fences forming the south-eastern and southwestern boundaries of the said Sports Club Ground (thereby crossing the boundary which divides the said Parish of Hayes from the said Parish of West Wickham) for a distance of 15½ chains or thereabouts to the point where it meets the fence forming the south-eastern boundary of the Forder Sports Club Ground, and extending thence south-westward along the last mentioned fence for a distance of 121 chains or thereabouts to the point where it meets the fence forming the northern boundary of the Hayes Branch Line of the Southern Railway, and extending thence south-westward for a distance of I chain or thereabouts to a point in the middle of the said line of railway
