

Order No. 5701.

(Dated 6th April, 1938.)

**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 61).**

**SUBJECT.**

I. Contracts the Foot-and-Mouth Disease Infected Area around Pen-pedair-heol, Glamorgan, as from the 11th April, 1938, so as to comprise only the Area described in the Schedule.

II. Releases the Foot-and-Mouth Disease Infected Area around Pen-pedair-heol, Glamorgan, and revokes Order No. 5687, as from the 18th April, 1938.

**SCHEDULE.**

*Contracted Infected Area.*

**IN THE COUNTY OF GLAMORGAN.**

The county borough of Merthyr Tydfil.

*In the petty sessional divisions of Caerphilly Higher and Caerphilly Lower.*

The parish of Llanfabon; so much of the parish of Gelligaer including its detached part as lies to the south of the railway line running from Dowlais via Rhymney Bridge Station to Beaufort Station and so much of the parish of Eglwysilam as lies to the north and north-west of the road running from Bedwas via Porset, Caerphilly, Beddau, Penrhos House, Nantgarw Halt and Willowford to Pontypridd.

*In the petty sessional division of Miskin Lower.*

So much of the parish of Pontypridd as lies to the east of the River Taff.

*In the petty sessional division of Miskin Higher.*

So much of the parish of Llanwonno as lies to the east of the River Taff.

**IN THE COUNTY OF MONMOUTH.**

*In the petty sessional division of Bedwelty.*

The parishes of Bedwas, Mynyddislwyn, Bedwelty, and so much of the parish of Abercarn as lies to the west of the Great Western Railway line running from Abertillery via Newbridge Station to Risca.

*In the petty sessional division of Newport.*

So much of the parish of Risca as lies to the north and the west of the boundary formed by the Sirhowy River and the Ebbw River.

Order No. 5702.

(Dated 6th April, 1938.)

**SUBJECT.**

Provides for the movement of imported animals landed at an approved landing-place into the Controlled Area (described in the First Schedule to Order No. 5695) and prescribes the conditions under which such movements shall be made.

Prohibits the holding of markets and sales of Imported animals in the Controlled Area.

**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1930 (No. 62).**

**SUBJECT.**

Declares the Area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

**SCHEDULE.**

An Area comprising:—

**IN THE COUNTY OF DERBY.**

The borough of Chesterfield.

The petty sessional divisions of Eckington, Chesterfield (*except the parishes of Shirebrook, Pleasley, Glapwell and Ault Hucknall*), and Bakewell (*except the parishes of Wheston, Brushfield, Taddington, Blackwell, Chelmorton, Flagg, Sheldon, Monyash, Over Haddon, Nether Haddon, Stanton, Birchover, Winster, Ivonbrook Grange, Elton, Gratton, Middleton and Smerrill, Youlgreave, Harthill and Hartington Middle Quarter*).

*In the petty sessional division of Chapel-en-le-Frith.*

The parishes of Hope Woodlands, Derwent, Bamford, Thornhill, Aston, Hope, Edale, Castleton, Bradwell and Brough and Shatton.

*In the petty sessional division of Matlock.*

So much of the parish of Darley as lies to the north-west of the road running from Darley-bridge via Darleydale station, Sydnope Hall, and Roach House to Walton.

*In the petty sessional division of Alfreton.*

So much of the parish of Ashover as lies to the north of the road running from Stretton via Stubbinedge Hall, Ashover, Kelstedge, Slack and Amber Hill to Matlock.

**IN THE COUNTY OF NOTTINGHAM.**

The borough of Worksop.

*In the petty sessional division of Worksop.*

The parishes of Holbeck, Carlton in Lindrick, Hodssock, Wallingwells, and Styrrup.
