UNEMPLOYMENT INSURANCE ACTS, 1935-1936.

REFERENCES TO THE HIGH COURT OF JUSTICE UNDER SECTION 84 (1) (B) OF THE UNEMPLOYMENT INSURANCE ACT, 1935.

Pursuant to regulation 11 of the Unemployment Insurance (Determination of Questions) Regulations, 1936, the Minister of Labour hereby gives notice of his intention to refer to the High Court for decision questions that have arisen for his decision under Section 4 of the Unemployment Insurance Act, 1935, namely, whether the employment of certain persons on silver fox farms or fur farms is or is not employment in agriculture within the meaning of the Unemployment Insurance Acts, 1935 and 1936.

Under the Rules of the Supreme Court Order LV.B Rule 28, any person who claims to be interested in or affected by the decisions to be given in the above mentioned cases may apply to the Judge for leave to intervene.

The cases have been set down for hearing in the High Court and will, it is expected, be heard at no very distant date.
