THE BANKRUPTCY ACTS, 1914 AND 1926.

Whereas by Order of the Board of Trade dated the 9th day of May, 1938, Herbert Hornby Gaine was temporarily appointed as from the 9th day of May, 1938, an Official Receiver attached to the High Court of Justice in Bankruptcy in succession to Sydney Walter Hood.

Now therefore the Board of Trade do hereby appoint Herbert Hornby Gaine to be Official Receiver in the proceedings and of the estates in which the initial of the first surname of the debtor or debtors is any of the letters G to O.

And it is further ordered:—

(a) as regards the bankruptcy proceedings instituted under the Bankruptcy Acts, 1883 to 1926, which are pending in the High Court that the said Herbert Hornby Gaine shall be the Official Receiver of the estates of the debtors as aforesaid in such proceedings and discharge the duties of Official Receiver in relation to such estates.
