The Secretary of State for India has appointed Messrs. Ernest Johnson and James Pirie, Deputy Superintendents in the Mercantile Marine Office, Liverpool, to superintend the transfer of Lascars and other persons and to grant the certificate required under Section 125 of the Merchant Shipping Act, 1894 (57 and 58 Vic. Cap. 60).

The fee to be paid for every Lascar or other person in respect of whom such certificate is applied for is limited to three shillings, and in no case is the total amount of fees in respect of one crew to exceed five pounds.

RULES PUBLICATION ACT, 1893.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiry of at least forty days from this date in pursuance of the powers conferred upon him by the Finance Act, 1920, and the Roads Act, 1920, to make the Motor Vehicles (International Circulation) Amendment Regulations, 1938, to provide that on application for an International Circulation Permit it shall not be necessary for the applicant in the case of a vehicle registered in Italy to forward a fiscal permit with his application.
