RULES PUBLICATION ACT, 1893.

LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport after the expiry of at least forty days from this date in pursuance of the power conferred upon him by Section 10

of the aforesaid London Traffic Act to make the London Traffic (Parking Places) (Amendment) No. 9 Regulations, 1938:—

(1) to appoint parking places in Somerleyton Road and Geneva Road, Stockwell; Bromley Road, Leyton;

(2) to abolish a parking place on the East side of Old Town Hall, Reigate;

(3) to amend the method of parking on a parking place in Waterloo Place, Westminster.
