WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 16th day of June, 1938, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Mary, situate at Greenstreet Green, in the Parish of Chelsfield, in the County of Kent and in the Diocese of Rochester:

“ Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Mary, situate at Greenstreet Green as aforesaid:

“ Now, therefore, with the consent of the Right Reverend Martin, Bishop of Rochester (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said Parish of Chelsfield which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Mary, situate at Greenstreet Green, as aforesaid, and that the same should be named

‘ The District Chapelry of Saint Mary, Greenstreet Green ’.

“ And with the like consent of the said Martin, Bishop of Rochester (testified as aforesaid) we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said Church of Saint Mary, situate at Greenstreet Green as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being: Provided always that so long as the Reverend Bertram Parsons, the present Vicar or Incumbent of the Vicarage of the said Parish of Chelsfield shall continue to be such Vicar or Incumbent, all the fees or dues which may be received in respect of such publication, solemnization or performance at the said Church of Saint Mary, situate at Greenstreet Green as aforesaid, shall be paid over by the minister thereof to the said Bertram Parsons.

“ THE SCHEDULE to which the foregoing Representation has reference.

“ The District Chapelry of Saint Mary, Greenstreet Green, being:—

“ All that part of the Parish of Chelsfield, in the County of Kent and in the Diocese of Rochester, which is bounded upon all sides as follows, that is to say, upon the east and upon the south-east by the Parish of Halstead, upon part of the south by the Parish of Knockholt, upon the remaining part of the south and upon part of the south-west by the Parish of Cudham, upon the remaining part of the south-west by the Parish of Downe, upon the north-west by the Parish of Farnborough, upon part of the north-east by the Parish of Orpington, all in the said County and Diocese and upon the remaining part of the north-east by an imaginary line commencing at the point where the boundary which divides the said Parish of Orpington from the said Parish of Chelsfield diverges northward from following the middle of the Main Line of the Eastern Section of the Southern Railway, and extending thence south-eastward along the middle of the said line of railway for a distance of 1 mile and 21 chains or thereabouts to the boundary which divides the said Parish of Chelsfield from the said Parish of Halstead.”
