RULES PUBLICATION ACT, 1893.

IN THE MATTER OF THE LONDON TRAFFIC ACT,
1924.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiration of at least 40 days from this date in pursuance of the powers conferred upon him by Section 10 of the London Traffic Act, 1924, to make Regulations in regard to the undermentioned schemes of traffic working.

One-way traffic working.

1. At the junction of Church Road (A.3003) High Street (A.3003) and Station Road (B.349) Barnes.
2. Clarence Street, Richmond.
3. In the service roads in Warwick Garden at its junction with Kensington High Street.

Roundabout working.

4. At the junction of Links Way (A.214) South Eden Park Road and Monks Orchard Road, Beckenham.
5. At the junction of St. Martin's Lane (B.404) Cranbourn Street (B.402) Great Newport Street, Upper St. Martin's Lane (B.404) Long Acre (B.402) and Garrick Street, Westminster.
