The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS FOR THE APPOINTMENT OF MALE ASSISTANT SURVEYORS IN THE CIVIL ENGINEER-IN-CHIEF'S DEPARTMENT OF THE ADMIRALTY AND IN THE DIRECTORATE OF WORKS OF THE AIR MINISTRY.

N.B.—These Regulations are liable to alteration from time to time. Competitions do not take place at fixed intervals, but are held as occasion arises.

1. Candidates must have attained the age of 22 and must not have attained the age of 30 on a date to be fixed in respect of the competition in which they are to take part. Candidates who have served or are serving in the Army, Navy or Air Force may deduct from their actual age any time not exceeding five years during which they have so served.

2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case of natural-born British subjects who have satisfactorily completed a period of not less than five years' service on full pay in His Majesty's Regular Forces.

Provided also that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry and upbringing with His Majesty's dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a) the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalisation or by any other voluntary and formal act.

The consent of the authorities of the Department concerned will be required before the child of a naturalised British subject can be appointed either to the Admiralty or to the Air Ministry.

3. Persons holding situations in the Civil Service must obtain the permission of the authorities of their department to apply for appointment.

No person actually serving in the Army, Navy or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding
