Notice is hereby given that the Minister of Agriculture and Fisheries, in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, proposes to make an Order confirming a Scheme submitted to him by the River Great Ouse Catchment Board, under Section 4 (1) (b) of the Act, making provision for the extension of the period of office of the first members of the Whittlesey and Farcet Internal Drainage Board until the 1st day of November, 1939.
