Whereas by the Arms Export Prohibition Order, 1931, the export of certain goods is prohibited except under a licence of the Board of Trade;

And whereas on the 28th September, 1938, the operation of all licences (with certain exceptions) previously granted by the Board of Trade in connection with the said Order was suspended by direction of the Board during the period commencing on the said date and ending on the 16th October, 1938;

And whereas it is desirable that the suspension of the operation of the said licences should be cancelled as from the 4th October, 1938;

Now, therefore, the Board of Trade, in the exercise of all powers enabling them in that behalf, do hereby direct and declare that the operation of the said licences is restored with effect from the 4th October, 1938.
