Notification of Endemic Disease.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of 40 days from this date and in pursuance of the powers given to him by Section 143 of the Public Health Act, 1936, to make regulations entitled the Holborn (Acute Rheumatism) Regulations, 1938, providing for the notification of cases of acute rheumatism (as defined in the regulations) occurring in children under the age of 16 years within the Metropolitan Borough of Holborn.

BLACKBURN.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Blackburn (hereinafter called the Corporation) have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Blackburn Improvement Act, 1882, the Blackburn Corporation Act, 1892, the Blackburn Order, 1897, which was confirmed by the Local Government Board Provisional Orders Confirmation (No. 18) Act, 1897, the Blackburn Corporation Act, 1922, the Blackburn Order, 1925, which was confirmed by the Ministry of Health Provisional Orders Confirmation (No. 4) Act, 1925, and the Blackburn Corporation Act, 1929, so as

(1) To enable the Corporation, subject to certain conditions and restrictions, to exercise either wholly or partially any statutory borrowing power possessed by them by using for the purpose any moneys forming part, but not for the time being required for the purposes of:—

(a) The sinking fund established and formed in respect of the Blackburn Corporation Two and Three Quarters Per Cent. Redeemable Stock, 1960-1965.

(b) The sinking fund established and formed in respect of the Blackburn Corporation Three and a Half Per Cent. Redeemable Stock, 1962.

(c) Any other funds now or hereafter to be accumulated for the redemption of debt.

(2) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Acts, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application:

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the twenty-ninth day of October, 1938, by any person or body interested in the subject matter of the said Application and the proposed Provisional Order. IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.
