owners of property within the Borough of Huddersfield or the Urban District of Elland and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Council to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933,* the development of land in the said areas during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Council are empowered to permit other development in the said areas during this
