say:—
"We, the Ecclesiastical Commissioners for pursuance of the Act of the 33rd England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council the following Schome for effective Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called

'the said Benefice') of Acrise, in the County of Kent and in the Diocese of Canterbury:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Acrise is vested for an estate in fee simple without incumbrances in Arthur Norman Watney, of Acryse Place, Folkestone, in the said County of Kent, Esquire:
"And whereas the said Arthur Norman

Watney is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Acrise now vested in him as aforesaid, should be transferred to and be vested in the Archbishop of Canterbury for the time being:

And whereas the Right Honourable and Most Reverend Cosmo Gordon, now Archbishop of Canterbury, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has

that consent of the Bishop of the Diocese which by the hereinbefore mentioned Acts or by some or one of them is made necessary he, the said Cosmo-Gordon, Archbishop of Canterbury, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Acrise which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the parish of Acrise:

"Now, therefore, with the consent of the said Arthur Norman Watney (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Cosmo Gordon, Archbishop of Canterbury (in testimony whereof he has signed this Scheme and sealed the same with his Archiepiscopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Acrise now vested in him, the said Arthur Norman Watney, as aforesaid, shall be trans-ferred to the said Cosmo Gordon, Archbishop of Canterbury, and his successors in the same Archbishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Cosmo Gordon, Archbishop of Canterbury, and by his successors in the same Archbishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."
