

(such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District, and when such District shall have become a New Parish then of the said New Parish and the nomination of the Minister or Incumbent thereof should be assigned in the manner which is hereinafter set forth:

" And whereas the contributors of the said capital sum of £2,000 have nominated to us the Bishop of Coventry for the time being as the person to whom they desire that the whole right of Patronage of the said proposed District or New Parish should be assigned:

" Now, therefore, with the consent of the Right Reverend Mervyn, Bishop of Coventry (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said Parish of Stoneleigh and of the said New Parish of Westwood which are described in the Schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be constituted a separate District for spiritual purposes and that the same shall be named ' The District of Saint Martin, Finham.'

" And we further recommend and propose that the whole right of Patronage of the said District so recommended to be constituted and, when such District shall have become a New Parish as aforesaid, then of such new Parish and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid, be assigned to and be absolutely vested in and shall and may from time to time be exercised by the said Mervyn, Bishop of Coventry, and his successors for ever.

" And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

" THE SCHEDULE to which the foregoing Scheme has reference.

" The District of Saint Martin, Finham, comprising:—

" I. All that portion of the Parish of Stoneleigh, in the County of Warwick and in the Diocese of Coventry which is bounded upon the north-east and upon the north by the Parish of Stivichall, upon the north-west by the New Parish (sometime Chapelry District) of Westwood, both in the said County and Diocese, and upon the remaining sides, that is to say, upon the south-west and upon the south-east, by an imaginary line commencing upon the boundary which divides the said New Parish of Westwood from the said Parish of Stoneleigh at the junction of Kenilworth Road with the roadway or footpath leading past the southern side of Wainbody Wood, and extending thence south-eastward along the

middle of the said roadway or footpath for a distance of 65 chains or thereabouts to its junction with the roadway or footpath leading through Kings Hill into Green Lane, and extending thence north-eastward along the last mentioned roadway or footpath for a distance of 71 chains or thereabouts to its junction with Green Lane, and extending thence south-eastward along the middle of Green Lane for a distance of 3 chains or thereabouts to its junction with Howes Lane, and extending thence north-eastward along the middle of Howes Lane for a distance of 41 chains or thereabouts to the centre of the bridge or culvert which carries it across the stream called Martin Gutter upon the boundary which divides the said Parish of Stoneleigh from the said Parish of Stivichall.

" II. And also all that portion of the said New Parish of Westwood which is bounded upon the south and upon the east by the above described portion of the said Parish of Stoneleigh, upon the north by the said Parish of Stivichall, and upon the remaining side, that is to say, upon the west, by an imaginary line commencing at the point where the boundary which divides the said Parish of Stivichall from the said New Parish of Westwood crosses the middle of Kenilworth Road, and extending thence south-westward along the middle of Kenilworth Road for a distance of 18½ chains or thereabouts to the boundary which divides the said New Parish of Westwood from the said Parish of Stoneleigh."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Coventry.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th
