## Board of Trade.—1938.

## CHEPSTOW GAS.

(Application for Special Order under Gas Undertakings Acts, 1920 to 1934.)

NOTICE is hereby given that application is intended to be made to the Board of Trade by the Chepstow Gas Company (hereinafter called "the Company") whose address is St. Mary Street Chepstow in the County of Monmouth, for a Special Order under the Gas Undertakings Acts, 1920 to 1934, for all or some of the following purposes (that is to say):—

1. To extend the limits within which the Company are authorised to supply gas so as to include:—

## In the County of Monmouth.—

The parishes of Caldicot, Llanvihangel near Roggiett, Portskewett, Rogiet and Undy in the rural district of Chepstow, so much of the parish of Mathern in that rural district as was comprised before the first day of April 1935 in the parish of Portskewett, so much of the parish of Caerwent in that rural district as was not comprised in the parishes of Llanvair Discoed and St. Brides Netherwent before the first day of April 1935 and so much of the parishes of Tintern and Shirenewton in that rural district as are not within the existing limits;

So much of the parish of Trellech United in the rural district of Monmouth as lies within three miles in a straight line from any part of the Church of St. Michaels at Tintern Parva;

## In the County of Gloucester.—

The parishes of Alvington, Hewelsfield and St. Briavels in the rural district of Lydney and so much of the parish of Woolaston in that rural district as is not within the existing limits;

(hereinafter called "the added limits") and to provide that subject to the provisions of the intended Order the Company shall have and may exercise within the added limits or any part or parts thereof all powers rights and privileges which they have within their existing limits of supply or some part or parts thereof.

2. To authorise the purchase by the Company of the gas undertaking of the Caldicot and District Gas Light and Coke Company Limited (hereinafter called "the Caldicot Company") upon the terms (with or without modification) of an agreement dated the 6th day of September, 1938, and made between the Caldicot Company of the one part and the Company of the other part, and to vest the said undertaking in the Company.
