FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 105).

SUBJECT.

Declares the Area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

SCHEDULE.

An Area comprising:—

IN THE COUNTY OF GLAMORGAN.

The city and county borough of Cardiff (except Flat Holm).

The borough of Cowbridge.

The petty sessional divisions of Dinas Powis, Cowbridge, Kibbor, Miskin Lower, Caerphilly Lower (except so much of the parish of Gelligaer as lies to the north of the road running from Tair-heol via Tophill, Heol Adam, Gelligaer Church, Pen-pedair-heol and Pengam to Charlestown and except the said road) and Newcastle and Ogmere (except the parishes of Llangynwyd Higher, Cwmdau, Llangynwyd Middle, Pyle, Kenfig, Sker and Newton Nottage).

*In the petty sessional division of
Miskin Higher.*

The parish of Llanwonno.

IN THE COUNTY OF MONMOUTH.

So much of the city and county borough of Cardiff as lies within the County.
