Notice is hereby given in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Order:—

Order No. 5769.

(Dated 21st November, 1938.)

FOOT-AND-MOUTH DISEASE (INFECTED
AREAS) ORDER OF 1938 (No. 106).

SUBJECT.

I. Contracts the Foot-and-Mouth Disease Infected Area around Warfield, Berkshire, as from the 25th November, 1938, so as to comprise only the area described in the Schedule.

II. Releases the Foot-and-Mouth Disease Infected Area around Warfield, Berkshire, from restrictions, and revokes Order No. 5767 as from the 2nd December, 1938.

SCHEDULE.

Contracted Infected Area.

An Area comprising:—

IN THE COUNTY OF BERKSHIRE.

So much of the borough of Wokingham as lies to the east of the Southern Railway line running from Reading to Sandhurst and so much of the borough of Maidenhead as lies to the south of the Great Western Railway line running from Burnham Beeches to Twyford.

*In the petty sessional division of
Forest.*

The parishes of Binfield, Warfield, Waltham St. Lawrence and St. Nicholas Hurst; so much of the parishes of East Hampstead and Wokingham Without as lies to the north and east of the following boundary, namely:—the road running from Penny Hill via Red Lodge, Ninemile Ride and Heathlands Church as far as its junction with the Southern Railway line running from Sandhurst to Wokingham and thence along the said railway line to Wokingham, and so much of the parishes of Twyford, Ruscombe and Wargrave as lies to the south-east of the main road running from Sonning via Twyford and Hare Hatch to Knowl Hill Church.

*In the petty sessional division of
Maidenhead.*

The parishes of Bray, White Waltham and Shottesbrooke and so much of the parish of Hurley as lies to the south-east of the road running from Hare Hatch via Knowl Hill Church, Littlewick Green, Woolley Green and Maidenhead Thicket to Maidenhead.

*In the petty sessional division of
Windsor.*

The parish of Sunninghill and so much of the parish of Winkfield as lies to the north of the road running from Bagshot via Bagshot Park, Penny Hill and Red Lodge to East Hampstead.
