or other easements belonging thereto and subject to such special conditions restrictions and provisions as the Undertakers may think fit and to enable persons under disability to grant

- 16. To make new provisions as to the sale of capital of the Undertakers by auction or -tender; to empower the directors of the Undertakers to reserve a proportion of any issue of capital for exclusive offer to consumers of water and to the employees of the Undertakers and to make provisions as to the conditions of issue and to authorise the Undertakers to offer capital to such consumers and employees as aforesaid at a fixed price and to offer capital for subscription by the public.
- 17. To make provision for the borrowing of further money by the Undertakers notwithstanding the limitation imposed by the Swaffham Water Order 1891.
- 18. To authorise the application of the revenues of the undertaking for the provision of gratuities pensions and other allowances for ants of deceased employees and for the making employees of the Undertakers and the dependof subscriptions to hospitals and other charitable objects and to the benevolent and sick funds of the employees.
- 19. To amend section 35 of the Waterworks Clauses Act 1847 in its application to the
- 20. To empower the Undertakers to demand the payment of water rates half-yearly in
- 21. To empower the Undertakers to require. water rates to be paid by owners of small houses or houses let to tenants on less than a quarterly tenancy.
- 22. To make provision for determining the amount of water rate chargeable by the Under- takers in respect of any supply of water where two or more houses are in one occupation.
- 23. To make special provisions as to the supply of water to caravans shacks huts tents and similar structures and as to the terms and conditions of any such supply.
 - 24. To provide that the Undertakers may in the case of dwelling-houses partly used for trade or manufacturing purposes and of certain classes of buildings institutions and premises and of farm-houses require water to be taken and paid for by measure.
- 25. To authorise the Undertakers to make special or increased charges for water used in premises where horses carriages or motor cars are kept and also in cases where water is used by means of a stand-pipe tap hose-pipe or similar apparatus or for or in connection with refrigerating and other apparatus or for other special purposes.
- 26. To make provision as to the charges to be made by the Undertakers for a supply of water to swimming baths and bathing pools.
- 27. To prescribe the minimum charges to be made by the Undertakers for certain supplies.
- 28. To provide for the seizure and detention of the goods and chattels of persons quitting or about to quit premises supplied by the Undertakers with water who have failed to pay their water rates or charges and intend to evade payment of the same.
- 29. To require the provision of cisterns of

may specify in any dwelling-house to be erected on land situate at a higher level than that which may be prescribed by the intended Order and to relieve the Undertakers from any obligation to supply any such dwelling-house until such cisterns are provided.

- 30. To provide that the Undertakers shall not be bound to supply more than one house by the same communication pipe, to enable them to require the owner of any house to lay a separate pipe from the main to that house and to place upon the owners and occupiers of premises supplied by a common pipe the liability to contribute in such proportions as the intended Order may prescribe to the expenses incurred by the Undertakers in the maintenance and repair of such pipe.
- 31. To make provisions requiring the insertion and maintenance of stop-cocks (including covers and boxes) and apparatus in communication pipes.
- 32. To confer on the Undertakers the exclusive right of connecting communication pipes with their mains.
- 33. To make new or additional provisions with respect to the following matters:—the notice to be given by consumers for the discontinuance of a supply of water; the making of byelaws for preventing the waste undue consumption misuse or contamination of water and as to the testing and stamping of sttings and apparatus and the charges therefor; the penalties for forging or counterfeiting stamps or marks used by or under the authority of the Undertakers and for using or supplying articles with any such stamp or mark knowing the same to be forged or counterfeited; the repair of communication pipes by the Undertakers and the recovery of the cost thereof; the selling or letting of meters and fittings; the connecting or disconnecting of meters; register of meters to be prima facie evidence of the quantity of water consumed; the imposition of penalties in the case of any person injuring any fitting or pipe or any meter or other instrument or preventing the same from registering or fraudulently abstracting consuming or using water; the imposition of penalties for opening or closing valves or other apparatus without the authority of the Undertakers and for other breaches of the provisions of the Order.
- 34. To extend the hours during which officers of the Undertakers may enter premises supplied with water by the Undertakers for the purposes of inspection; to provide for penalties in the case of any person hindering such officers from entering or making inspections; and to amend section 57 of the Waterworks Clauses Act 1847 in its application to the Undertakers.
- 35. To make provision as to the supply of materials by the Undertakers and the recovery of the charges therefor.
- 36. To exempt meters and fittings let on hire by the Undertakers from distress &c.; to make provision as to fittings let for hire remaining the property of the Undertakers; and to extend the powers of the Undertakers to enter premises and remove pipes meters and fittings belonging to them.
- 37. To confer upon consumers the like power to open the ground for repairing and maintainsuch minimum capacity as the intended Ordering pipes stop-cocks and apparatus as they
