3. The superintendent registrar of the existing Dewsbury district shall be the superintendent registrar of the Spen Valley district as constituted by this Order.

4. The functions under the Registration Acts in relation to the Dewsbury district as constituted by this Order are hereby transferred to the Council of the County Borough of Dewsburv.
