COUNTY PALATINE OF CHESTER.

ROAD AND RAIL TRAFFIC ACT, 1933.

NOTICE is hereby given that on the 25th November, 1938, the Minister of Transport modified and confirmed the County Council of the County Palatine of Chester Roads (Restriction) Amendment Order, 1938, made by the County Council of the County Palatine of Chester under Section 29 of the Road and Rail Traffic Act, 1933. The Order as modified and confirmed amends the County Council of the County Palatine of Chester Roads (Restriction) Order, 1937 (No. 2), which inter alia prohibited, with certain exceptions, the driving of motor vehicles on Meols Parade, North Parade and South Parade, Hoyslake, by providing that vehicles proceeding to or from any road on the Sandhey Estate shall be exempt from the provisions of that Order.

The Order is available for inspection at the County Offices, St. John's House, Chester.
