

the County Borough of Bradford will, on the 1st day of January, 1939, in consequence of and by virtue of the Bradford Registration Scheme, 1938, made by the Council of the County Borough of Bradford and approved by the Minister of Health under Section 24 of the Local Government Act, 1929, become a separate superintendent registrar's district and sub-districts respectively;

And whereas it is expedient that provision should be made for the division of the said separate superintendent registrar's district and the union of the parts with certain other contiguous superintendent registrars' districts, for the union or re-arrangement of the sub-districts comprised in the superintendent registrars' districts so extended, and for the formation of new sub-districts;

And whereas it is necessary to transfer the functions under the Registration Acts in relation to the area to be added to the Leeds South superintendent registrar's district;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, Section 21 (2) of the Local Government Act, 1929, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.—(1) This Order may be cited as the Bradford, Leeds and County of York, West Riding Registration of Births, etc., Order, 1938, and shall come into operation on the 1st day of January, 1939.

(2) In this Order the term "district" means a superintendent registrar's district, and the terms "existing district" and "existing sub-district" mean a district or sub-district which existed immediately before the 1st day of January, 1939.

2. The parishes specified in the first column of the Schedule hereto (being situate in the administrative county or county borough specified in the second column thereof) shall be united with the districts specified in the third column thereof and shall be added to and form part of or be constituted the sub-districts specified in the fourth column thereof.

3. The districts and the sub-districts extended or constituted under Article 2 of this Order shall be designated by the names respectively appearing in the third and fourth columns of the Schedule hereto.

4. The superintendent registrar of any existing district with which another district is united by virtue of Article 2 of this Order shall be the superintendent registrar of the united district.

5. The registrar of any existing sub-district which is extended by this Order shall be the registrar of that sub-district as so extended.

6. The registrars of the existing Cleckheaton, Shipley, Calverley and Pudsey sub-districts shall respectively be the registrars of the Cleckheaton, Shipley, Calverley and Pudsey sub-districts constituted by this Order.

7. The functions under the Registration Acts in relation to that part of the parish of Leeds which is added to the Leeds South district by this Order are hereby transferred to the Council of the County Borough of Leeds.
