

ORDER OF THE REGISTRAR-GENERAL
IN ENGLAND.

(Dated 14th October, 1938.)

No. 14/1938.

Whereas under Section 11 of the Births and Deaths Registration Act, 1837, the Registrar-General, with the approval of the Minister of Health, may divide any superintendent registrar's district into two or more superintendent registrars' districts;

And whereas it is expedient that the Wakefield superintendent registrar's district should be divided into two superintendent registrars' districts;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Section 11 of the Births and Deaths Registration Act, 1837, Section 21 (2) of the Local Government Act, 1929, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.—(1) This Order may be cited as the Wakefield Registration of Births, etc., Order, 1938, and shall come into operation on the 1st day of January, 1939.

(2) In this Order the term "district" means a superintendent registrar's district, and the term "existing district" means a district which existed immediately before the 1st day of January, 1939.

2.—(1) The existing Wakefield district shall be divided into two districts called respectively the Wakefield and the Lower Agbrigg districts.

(2) The Wakefield district shall consist of that portion of the existing Wakefield district which is situate within the County Borough of Wakefield.

(3) The Lower Agbrigg district shall consist of that portion of the existing Wakefield district which is situate within the Administrative County of York, West Riding.

3. The superintendent registrar of the existing Wakefield district shall be the superintendent registrar of the Lower Agbrigg district as constituted by this Order.
