- 2. To authorise the Company to charge differential prices within the added limits.
- 3. To authorise the Company to provide, maintain and equip recreation grounds for their employees and to acquire and hold lands for
- 4. To empower the Company to purchase by agreement any debentures or debenture stock of the Company and to apply their funds for the purpose and to provide that any debentures or debenture stock so purchased shall be cancelled.
- 5. To make new or further provision with reference to the Company's affairs including provisions as to:—scale of voting, relief of the Company from obligations to see to the execution of trusts, the indemnity which may be required before the issue of substituted certificates &c., the appointment, removal, retirement, remuneration and powers of a managing director, and notice of opposition to the re-election of a retiring director.
- 6. To make provision with respect to the following matters:—the position of meters; exemption from distress and removal by the Company of fittings, etc. let for hire or disposed of on terms of payment by instalments; the inspection and testing of meters; the acquisition holding and use of patent rights or licences by the Company and the application for and the grant of patents by and to the Company jointly with other persons; the recovery of sums due or payable to the Company in respect of the sale or hire of apparatus and fittings or the provision of materials and work in connection therewith or the fixing, setting up, repairing, altering, maintaining or removal thereof; and the recovery of demands and penalties and the inclusion of several sums in one summons.
- 7. To confer upon the Company all or any powers commonly conferred on gas undertakers and not hereinbefore referred to and to enact all such provisions as may be deemed expedient for effecting the purposes of the Order.

8. To repeal alter or amend all or some of the provisions of the Cambridge University and Town Gas Acts 1867 and 1899 and the Cambridge University and Town Gas Order 1921 and any other Act or Order relating to the Company or their undertaking.

9. To incorporate with the Order with or without exception or modification or to render inapplicable or to modify in their application to the Company all or some of the provisions of the Gasworks Clauses Acts 1847 and 1871, the Lands Clauses Acts, the Companies Clauses Consolidation Act 1845 and the Companies

Clauses Act 1863.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.r, and despatched on or before the 14th day of January, 1939. Any such objection must state (a) the specific grounds of objection and (b) the omissions, additions, or modifications asked for, and a copy thereof must at the same time be forwarded to the undermentioned Solicitor or Parliamentary Agents.
