**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 9 OF 1938.**

**SUBJECT.**

Contracts the Foot-and-Mouth Disease Infected Area around Rowsham, Buckinghamshire so as to comprise only the area described in the Schedule, and revokes Order No. 5782, as from the 24th December, 1938.

**SCHEDULE.**

An Area comprising:—

**IN THE COUNTY OF BEDFORDSHIRE.**

The boroughs of Luton and Dunstable.

The petty sessional division of Leighton Buzzard.

*In the petty sessional division of Woburn.*

The parishes of Tilsworth, Chalgrave, Hockliffe, Battlesden, Toddington, Harlington, Milton Bryan, Potsgrove, Woburn, Aspley Heath, Eversholt and Tingrith; and so much of the parishes of Aspley Guise, Husborne, Crawley and Ridgmont as lies to the south of the Cambridge and Bletchley Branch Line of the London Midland and Scottish Railway.

*In the petty sessional division of Ampthill.*

The parish of Westoning.

*In the petty sessional division of Luton.*

The parishes of Studham, Whipsnade, Kensworth, Caddington, Totternhoe, Houghton Regis, and Sundon.

**IN THE COUNTY OF BUCKINGHAM.**

The borough of Aylesbury.

The petty sessional divisions of Aylesbury and Linslade.

*In the petty sessional division of Fenny Stratford.*

The parishes of Great Brickhill, Little Brickhill, Bew Brickhill, Bletchley, Newton Longville and Stoke Hammond; and so much of the parishes of Wavendon and Woburn Sands as lies to the south of the Cambridge and Bletchley Branch Line of the London Midland and Scottish Railway.

*In the petty sessional division of Winslow.*

The parishes of Drayton Parslow, Mursley, Dunton, Hoggaston, Creslow, Whitchurch, Pitchcott, Quanton, Hogshaw, North Marston, Oving, East Claydon, Grandborough, Swanbourne, Tattenhoe, Winslow and Little Horwood; and so much of the parishes of Great Horwood and Whaddon as lies to the east and south of the road running from Winslow via Great Horwood Church, The Common, Grove Farm, Parkhill Farm and Woodpond Farm to Bletchley.

The Parishes of Chearsley, Ashendon and Woodham; so much of the parishes of Long Crendon and Chilton as lies to the east of the road running from Thame via Field Farm, Old Windmill, Easington, Chilton Church and Dortonhill to Dorton; and so much of the parish of Wotton Underwood as lies to the east of the railway line running from Haddenham to Calvert Station.

*In the petty sessional division of Wycombe (County).*

The parishes of Hughenden, Bradenham, Bledlow-cum-Saunderton and Radnage; and so much of the parishes of West Wycombe (including its detached part) and Stokenchurch as lies to the north of the road running from Chepping Wycombe via West Wycombe, Studley Green and Stokenchurch to Oxford.
