or fence forming the northern boundary of the said Nursery, and extending thence north-westward along the last-mentioned wall or fence for a distance of 12 chains or thereabouts to the point where it meets the wall or fence forming the western boundary of certain allotment gardens, and extending thence northeastward along the last-mentioned wall or fence and in a straight line in continuation thereof for a distance in all of 72 chains or thereabouts to a point in the middle of the road called Sidcup Hill and extending thence southeastward along the middle of Sidcup Hill for a distance of 13 chains or thereabouts to a point opposite to the southern end of the wall or fence forming the eastern boundary of the house and premises known as Number 153 Sidcup Hill, and extending thence north-eastward to and along such wall or fence and along the wall or fence in continuation thereof for a distance of 81 chains or thereabouts to the boundary which divides the said New Parish of Saint John, Sidcup, from the said Parish of Foots Cray.

"The Fourth Schedule.

"The territory to be annexed to the said Parish of Saint Paul's Cray, comprising:

"I. All that portion of the said New Parish of Saint John, Sidcup, which is bounded upon the west by that portion of the same New Parish which is described in the second part of the First Schedule to this Scheme, upon the south by the said Parish of Saint Paul's Cray, upon the east by the said Parish of Foots Cray, and upon the north by the middle of Sidcup By-pass Road.

"II. And also all that portion of the said Parish of Foots Cray which is bounded upon the east and upon the south by the said Parish of Saint Paul's Cray, upon the west by the last described portion of the said New Parish of Saint John, Sidcup, and upon the north by the middle of Sidcup By-pass Road."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Measures, and Notices have been transmitted to the persons or bodies entitled under the said Measures to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Measures:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners.

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Rochester has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measures.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Rochester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measures 1923 to 1936, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 24th day of November, 1938, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice (being a Rectory) of Dufton with a part of the Benefice (being a Rectory) of Long Marton, both of which Benefices are situate in the County of Westmorland and in the Diocese of Carlisle:

"Whereas Commissioners appointed at our request by the Right Reverend Henry Herbert, Bishop of Carlisle, pursuant to the provisions of the said Measures to inquire into and report upon the union of the said Benefice of Dufton with a part of the said Benefice of Long Marton duly made their Report to the said Bishop of Carlisle and therein recommended such union and the terms for effecting the same, and the said Bishop of Carlisle signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said union which Scheme is based upon the terms recommended in the said Report:

"And whereas both of the said Benefices of Dufton and Long Marton are now full the Reverend Victor Frederick Lindsay being the present Incumbent of the said Benefice of Dufton and the Reverend Canon Robert William Harris being the present Incumbent of the said Benefice of Long Marton:

"And whereas the patronage of each of the said Benefices of Dufton and Long Marton now belongs to one and the same Patron:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Henry Herbert, Bishop of Carlisle (testified by his signing this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"I. That the said Benefice of Dufton and the part of the said Benefice of Long Marton which is described in the Schedule annexed
