

Parish of Saint Luke, Milns Bridge, from the said New Parish of Saint Barnabas, Crosland Moor.

“ III. And also all that portion of the New Parish of Emmanuel, Lockwood, in the said County and Diocese, which is bounded upon the north-west and upon the south-west by the said New Parish of Saint Barnabas, Crosland Moor, and upon the remaining sides, that is to say, upon the south-east and upon the east, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Barnabas, Crosland Moor, from the said New Parish of Emmanuel, Lockwood, at a point in the middle of Dryclough Road opposite to the western end of the wall or fence forming the northern boundary of the houses and premises situate on the northern side of Woodside Road, and extending thence north-eastward along the said wall or fence for a distance of 24 chains or thereabouts to a point distant 50 yards from the western side of Moor End Road, and extending thence northward in a line parallel to and at a distance of 50 yards from the western side of Moor End Road for a distance of 16 chains or thereabouts to the boundary which divides the said New Parish of Emmanuel, Lockwood, from the said New Parish of Saint Barnabas, Crosland Moor.

“ The Fourth Schedule.

“ The territory to be annexed to the said New Parish of Emmanuel, Lockwood, comprising:—

“ I. All that portion of the New Parish of the Holy Trinity, South Crosland, in the said County and Diocese, which is bounded upon the north-east by the said New Parish of Emmanuel, Lockwood, upon the north-west by the said New Parish of Saint Barnabas, Crosland Moor, and upon the remaining sides, that is to say, upon the west, upon the south-west and upon the east by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Barnabas, Crosland Moor, from the said New Parish of the Holy Trinity, South Crosland, at the point in the middle of Woodside Road where the boundary of the said County Borough of Huddersfield turns southward to follow the western side of Butter Nab Road, and extending thence first south-eastward (thereby following the western side of Butter Nab Road) then north-westward and then eastward along such County Borough Boundary for a distance in all of 50 chains or thereabouts to the boundary which divides the said New Parish of the Holy Trinity, South Crosland, from the said New Parish of Emmanuel, Lockwood.

“ II. And also all that portion of the New Parish of Rashcliffe, in the said County and Diocese, which is bounded upon the west by the said New Parish of Saint Barnabas, Crosland Moor, upon the south by the said New Parish of Emmanuel, Lockwood, and upon the remaining sides, that is to say, upon the east and upon the north, by an imaginary line commencing at the point where the boundary which divides the said New Parish of Emmanuel, Lockwood, from the said New Parish of Rashcliffe, crosses the middle of North Street, and extending thence northward along the middle of North Street for a distance of $8\frac{1}{2}$ chains or thereabouts to its junction with Yews Hill

Road, and extending thence south-westward along the middle of Yews Hill Road for a distance of 8 chains or thereabouts to the boundary which divides the said New Parish of Rashcliffe from the said New Parish of Saint Barnabas, Crosland Moor.

“ III. And also all that other portion of the said New Parish of Rashcliffe which is bounded upon the south-west by the said New Parish of Emmanuel, Lockwood, and upon the remaining sides, that is to say, upon the north-west, upon the north-east, and upon the south-east, by an imaginary line commencing at the point where the boundary which divides the said New Parish of Emmanuel, Lockwood, from the said New Parish of Rashcliffe, crosses the middle of Lockwood Road, and extending thence north-eastward along the middle of Lockwood Road for a distance of 2 chains or thereabouts to its junction with the road leading to Lockwood Spa Baths, and extending thence south-eastward along the middle of the last mentioned road for a distance of $4\frac{1}{2}$ chains or thereabouts to a point in the wall or fence forming the north-western boundary of the said Baths, and extending thence south-westward along such wall or fence for a distance of $1\frac{1}{2}$ chains or thereabouts to the point where it reaches the north-eastern side of Spa Terrace, and extending thence south-westward in a straight line for a distance of 5 yards or thereabouts to a point in the middle of Spa Terrace upon the boundary which divides the said New Parish of Rashcliffe from the said New Parish of Emmanuel, Lockwood.

“ The Fifth Schedule.

“ The territory to be dissevered from the said New Parish of Emmanuel, Lockwood, and to be annexed to the said New Parish of Rashcliffe, being:—

“ All that portion of the said New Parish of Emmanuel, Lockwood, which is bounded upon the north by the said New Parish of Rashcliffe and upon the remaining sides, that is to say, upon the west, upon the south, and upon the east, by an imaginary line commencing at the point where the boundary which divides the said New Parish of Rashcliffe from the said New Parish of Emmanuel, Lockwood, crosses the middle of North Street, and extending thence southward along the middle of North Street for a distance of 4 chains or thereabouts to its junction with Armitage Crescent, and extending thence first eastward and then south-eastward along the middle of Armitage Crescent for a distance of $5\frac{3}{4}$ chains or thereabouts to its junction with Victoria Road, and extending thence north-eastward along the middle of Victoria Road for a distance of 10 chains or thereabouts to its junction with Mount Street, and extending thence south-eastward along the middle of Mount Street for a distance of $7\frac{1}{2}$ chains or thereabouts to its junction with Lockwood Road, and extending thence north-eastward along the middle of Lockwood Road for a distance of 3 chains or thereabouts to the boundary which divides the said New Parish of Emmanuel, Lockwood, from the said New Parish of Rashcliffe.
