Council, a Scheme bearing date the 15th day of December, 1938, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the following Parishes, namely, the New Parish of Saint George, Bickley, the New Parish of Saint Andrew, Bromley, the New Parish of Saint John the Evangelist, Bromley, the Parish of Chislehurst, the New Parish of Christ Church, Chislehurst, and the New Parish of the Annunciation, Chislehurst, all in the County of Kent and in the Diocese of Rochester:

"Whereas it has been represented to us, the said Ecclesiastical Commissioners, and it appears to us to be desirable that the boundaries of the said New Parish of Saint George, Bickley, of the said New Parish of Saint Andrew, Bromley, of the said New Parish of Saint John the Evangelist, Bromley, of the said Parish of Chislehurst, of the said New Parish of Christ Church, Chislehurst, and of the said New Parish of the Annunciation, Chislehurst, should be altered in the manner which is hereinafter mentioned:

"And whereas the Benefices of Saint George, Bickley; Saint Andrew, Bromley; Saint John the Evangelist, Bromley; Chislehurst; Christ Church, Chislehurst; and the Annunciation, Chislehurst, are now full, the Reverend Hugh Glaisyer, being the present Incumbent of the Benefice of Saint George, Bickley, the Reverend James Martin Tudor Griffiths being the present Incumbent of the Benefice of Saint Andrew, Bromley, the Reverend William Ralph Musselwhite being the present Incumbent of the Benefice of Saint John the Evangelist, Bromley, the Reverend John Reginald Bertrand Bradley Lumb being the present Incumbent of the Benefice of Chislehurst, the Reverend John Carpenter being the present Incumbent of the Benefice of Christ Church, Chislehurst, and the Reverend Canon Reginald Sowray Greaves being the present Incumbent of the Benefice of the Annunciation, Chislehurst, and such Incumbents have signified their consents to the proposals hereinafter mentioned by signing this Scheme:

"And whereas no Diocesan Committee has been appointed for the said Diocese of Rochester pursuant to the first section of the Union of Benefices Measure, 1923:

"Now, therefore, with the consent of the Right Reverend Martin, Bishop of Rochester (in testimony whereof he has signed this Scheme), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Saint George, Bickley, of the said New Parish of Saint Andrew, Bromley, of the said New Parish of Saint John the Evangelist, Bromley, of the said Parish of Christ Church, Chislehurst, and of the said New Parish of the

Annunciation, Chislehurst, shall be altered so that (first) all that portion of the said New Parish of Saint John the Evangelist, Bromley, which is described in the First Schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured green, shall be annexed to and shall in future form part of the said New Parish of Saint Andrew, Bromley, (secondly) all those portions of the said New Parish of Saint John the Evangelist, Bromley, and of the said New Parish of the Annunciation, Chislehurst, which are described in the Second Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured pink shall be annexed to and shall in future form part of the said New Parish of Christ Church, Chislehurst, (thirdly) all that portion of the said New Parish of the Annunciation, Chislehurst, which is described in the Third Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured yellow shall be annexed to and shall in future form part of the said New Parish of Saint John the Evangelist, Bromley, (fourthly) all that portion of the said New Parish of Christ Church, Chislehurst, which is described in the Fourth Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured blue shall be annexed to and shall in future form part of the said New Parish of the Annunciation, Chislehurst, (fifthly) all that portion of the said Parish of Chislehurst which is described in the Fifth Schedule here-under written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured purple shall be annexed to and shall in future form part of the said New Parish of Saint George, Bickley, and (sixthly) all that portion of the said New Parish of Saint George, Bickley, which is described in the Sixth Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured brown shall be annexed to and shall in future form part of the said Parish of Chislehurst.

"And we further recommend and propose that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid, or any of them in accordance with the provisions of the said Measures, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.

"THE SCHEDULES to which the foregoing Scheme has reference.

## "THE FIRST SCHEDULE.

"The territory to be dissevered from the New Parish of Saint John the Evangelist, Bromley, in the County of Kent and in the Diocese of Rochester, and to be annexed to the New Parish of Saint Andrew, Bromley, in the said County and Diocese, being:—

"All that portion of the said New Parish of Saint John the Evangelist, Bromley, which is bounded upon the north by the New Parish of Saint Augustine, Grove Park, Lee, in the said County of Kent and in the Diocese of Southwark, upon the west by the said New
