than such duly gazetted Order the boundaries of the said Parish of Richmond, of the said Parish of Hudswell and of the said New Parish of Saint John the Evangelist, Hipswell, shall be altered so that (first) all those portions of the Extra Parochial Place known as Saint Martin's in the said County and Diocese, and of the said Parish of Hudswell which are described in the First Schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be annexed to and shall in future form part of the said Parish of Richmond and (secondly) all that portion of the said Extra Parochial Place known as Saint Martin's which is described in the Second Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured green shall be annexed to and shall in future form part of the said New Parish of Saint John the Evangelist, Hipswell.

And we further recommend and propose that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measures, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.

"THE SCHEDULES to which the foregoing Scheme has reference.

"THE FIRST SCHEDULE.

The territory to be annexed to the Parish of Richmond, in the County of York and in

the Diocese of Ripon, comprising:

"I. All that portion of the Extra Parochial Place known as Saint Martin's, in the said County and Diocese, which is bounded upon all sides as follows, that is to say, upon part of the north-east by the Parish of Easby, in the said County and Diocese, upon the remaining part of the north-east and upon the north; west by the said Parish of Richmond, upon the west by the Parish of Hudswell, in the said County and Diocese, and upon the south by the middle of the stream called Sand

"II. And also all that contiguous portion of the said Parish of Hudswell which is bounded upon the north by the said Parish of Richmond, upon the east by the above described portion of the said Extra Parochial Place known as Saint Martin's, upon the south by the New Parish of Saint John the Evangelist, Hips-well, in the said County and Diocese, and upon the remaining side, that is to say, upon the west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint John the Evangelist, Hipswell, from the said Parish of Hudswell at the centre of Sandbeck West Bridge, and extending thence north-eastward along the middle of the road leading from Leyburn to Richmond for a distance of 9½ chains or thereabouts to a point opposite to the southern end of the fence forming the western boundary of the close numbered 355A upon the Ordnance Survey Map of the Civil Parish of Hipswell published in the year 1928 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme, and extending thence northward to and along the said fence for a distance of 81

chains or thereabouts to the point where it reaches the southern side of the road leading from Hudswell to Holly Hill, and extending thence first northward to and then eastward along the middle of the said road for a distance of 4 chains or thereabouts to a point opposite to the southern end of the fence which divides the close numbered 353 upon the hereinbefore mentioned maps from the close numbered 354 upon the same maps, and extending thence first northward to such fence and then first northward and then in various directions along the fences which divide the said close numbered 353 and the closes numbered 352 and 313 upon the said maps from the said close numbered 354 and the closes numbered 349 and 351 upon the same maps for a distance in all of 17 chains or thereabouts to the point where the fence which divides the said close numbered 313 from the said close numbered 351 reaches the southern side of Boggy Lane, and extending thence first north-westward across Boggy Lane to and then northward along the fence forming the western boundary of the close numbered 334 upon the said maps for a distance in all of 3 chains or thereabouts to the point where such fence reaches the southern side of Low Bank Wood, and extending thence in a straight line due north for a distance of  $5\frac{1}{2}$  chains or thereabouts to a point in the middle of the River Swale upon the boundary which divides the said Parish of Hudswell from the said Parish of Richmond.

## "THE SECOND SCHEDULE.

"The territory to be annexed to the said New Parish of Saint John the Evangelist, Hips-

well, being:

"All that portion of the said Extra Parochial Place known as Saint Martin's which is bounded upon all sides as follows, that is to say, upon the east by the said Parish of Easby, upon the south-east and upon the south-west by the said New Parish of Saint John the Evangelist, Hipswell, and upon the north by the middle of the stream called Sand Beck.

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Measures, and Notices have been transmitted to the persons or bodies entitled under the said Measures to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Measures:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Ripon has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme
