## KNOTTINGLEY GAS.

(Application for Special Order under the Gas Undertakings Acts 1920 to 1934.)

NOTICE is hereby given that application is intended to be made to the Board of Trade by Knottingley Gas Company (hereinafter called "the Company") whose address is Gas Offices Knottingley for a Special Order under the Gas Undertakings Acts 1920 to 1934 for all or some of the following purposes (that is to say):—

1. To authorise the Company upon the land hereinafter described to erect maintain alter improve and renew works for the storage of gas with all necessary machinery and apparatus ancillary thereto and do all such acts as may be proper for storing gas and for supplying gas within their limits of supply.

The land before referred to is:—

A piece of land containing .964 acre or thereabouts situate in the urban district of Knottingley and being the enclosure numbered 361 in the parish of Knottingley on the <sup>2500</sup> Ordnance Map Yorkshire (West Riding) Sheet CCXXXV. 10. (Edition of 1933).

2. To repeal alter or amend all or some of the provisions of the Knottingley Gas Act and Orders 1856 to 1926.

3. To incorporate with the Order with or without modification or to render inapplicable all or some of the provisions of the Lands Clauses Acts the Gasworks Clauses Act 1847 and the Gasworks Clauses Act 1871.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the 23rd day of January, 1939.

Any such objection shall state:—

- (a) The specific grounds of objection, and
- (b) The omissions, additions or modifications asked for.

A copy of the objection must at the same time be forwarded to the undermentioned Solicitors or Parliamentary Agents.

A copy of the draft Special Order and an Ordnance Map showing the situation of the existing and proposed works and the boundaries of the area of supply of the Company and an Ordnance Map showing the land to be used for the storage of gas have been deposited for public inspection with the Clerk of the County Council of the Administrative County of the West Riding of York at his Office at Wakefield, and at the Offices of the Company, Gas Offices Knottingley.

## MINISTRY OF TRANSPORT.

ROAD TRAFFIC ACT, 1930—SECTION 46.

ROAD TRAFFIC ACT, 1934—SECTION 1.

ROAD AND RAIL TRAFFIC ACT, 1933—

WHEREAS in pursuance of Section 46 (1) of the Road Traffic Act, 1930, as amended by Section 29 of the Road and Rail Traffic Act, 1933, the Surrey County Council have made application to the Minister of Transport for confirmation of an Order made by them on 28th July, 1938, the effect of which is set out in the Schedule hereto.

And whereas by virtue of the Surrey County Council (Built-up Areas) (No. 1) Order, 1936, made by the Surrey County Council with the Minister's consent under Section 1 (4) of the Road Traffic Act, 1934, the length of road specified in Part III of the Schedule hereto was
